**ANNOUNCEMENT ON THE NON-ACCEPTANCE OF
THE APPLICATION IN RELATION TO NON-PUBLIC ISSUANCE OF
A SHARES BY CSRC**

References are made to (i) the announcement of Zhejiang Shibao Company Limited (the “**Company**”) dated 18 October 2022 and the circular of the Company dated 10 November 2022 (the “**Circular**”) in relation to, among other things, the proposed Non-public Issuance of A Shares; and (ii) the announcement of the Company dated 2 December 2022 in relation to, among other things, the poll results of the extraordinary general meeting and the class meeting for holders of H Shares of the Company held on 2 December 2022. Unless otherwise defined herein, capitalized terms used herein shall have the same meaning as defined in the Circular.

The Company recently received the “Notice of the non-acceptance of the application for Administrative Permission from the CSRC” (中國證監會行政許可申請不予受理通知書) issued by the CSRC (the “**Notice**”). The CSRC has examined the application materials for administrative permission submitted by the Company and considered that the application materials do not comply with the statutory form, thus it decided not to accept the application for administrative permission.

Having received the Notice, the Company will amend the application materials according to the requirements of the CSRC, and then resubmit the application to the CSRC.
